SEWER SYSTEM MANAGEMENT PLAN UPDATE

Director of Public Works (DPW) Eric Martin stated the Sewer System Management Plan (SSMP) is a regulatory document, and a planning and operations document. The SSMP is updated every two years then brought before the Board. The SSMP is inclusive of an emergency response plan and details preventative measures to avoid Sanitary Sewer Overflows (SSOs) as much as possible. The SSMP, emergency response planning, staff training, and reporting are all up to date.

- Several projects are commencing on the water system:
 - O New water filters for the water treatment plant set to arrive in June
 - O New motor for TH-1 set to arrive soon
 - O Well 3 is close to being back online
 - O Pumps replacement in Schaffer Mill Pump Station being performed by District operations staff
- Operations staff is in the shoulder season and focusing on fleet maintenance and gearing up for sewer system projects
