NEW BUSINESS

SCADA PLC AND CELLULAR RETROFIT CONSULTING SERVICES

Director of Public Works (DPW) Eric Martin stated that the serial radio hardware at the District's six remote water and sewer facilities is no longer produced or serviceable. District staff is proposing to replace the current radio telemetry infrastructure with cellular technology. Additionally, the current Programming Logic Computers (PLCs) used at the facilities are no longer supported. It is further proposed that the PLCs be replaced and programmed with updated software. The project expense has been approved as a part of the Fiscal Year 2024-25 budget. SCADA equipment replacement has also been contemplated as a part of the District's Capital Replacement Plan.

Director Ives moved to approve the SCADA PLC and Cellular Retrofit Consulting Services in an amount not to exceed \$319,800. Director Forni seconded; roll call was taken. Yes: Directors Brown, Forni, Ives, Radanovich and Witherspoon. Noes: None. Abstain: None. Absent: None. The motion carried.

GENERAL MANAGER'S REPORT - STAUDENMAYER

GM Staudenmayer provided the following report:

- NPOA board approved the Wood Energy Heat Purchase agreement
- The remaining heat purchase agreements have been through legal review or are pending approval.
- Met with Tahoe Truckee Sierra Disposal to discuss fuel procurement arrangements

FIRE DEPARTMENT - GIBEAUT

Fire Chief Jason Gibeaut provided the following report:

- GM Staudenmayer, Chief Gibeaut and Assistant General Manager (AGM) Mike Geary met with representatives from neighboring fire districts to discuss the development and scope for a LAFCO Municipal Services Review of fire service in eastern Placer County. Next meeting is scheduled for August 6, 2024. The initial study is expected to take one year.
- The NFD dispatched a type three engine to the Spring Valley Fire.

PUBLIC WORKS REPORT - MARTIN/RYAN

DPW Martin and Utilities Operations Manager (UOM) Matt Ryan provided the following report:

- The WEF is currently being reconfigured to a single boiler system with ceramic filtration
- Underground piping for the WEF is expected to be installed by the end of September with Northstar Drive repaying to be completed soon afterward.
- Due to high temps, there has been increased consumption for irrigation in both water systems.
- Staff has reduced construction costs through engineering solutions for Martis Valley Trail Segment 3F.
- Utilities Operations department promoted a long-term seasonal employee to full-time.
