Water-Efficient Toilet Replacement Rebate

Program and Submittal Information

The Water Efficient Toilet Rebate Program encourages customers to replace high-water use toilets to low water use toilets by providing increasing incentives for more efficient toilets. In 1992 the Federal toilet standards went into effect requiring toilets installed in new construction to use 1.6 gallons of water per flush or less. Many “older” homes and businesses still have high-water use toilets that use between 3 and 7 gallons per flush (GPF). Recent advancements have allowed toilets to use 1.28 gallons per flush or less while still providing equal or superior performance. This is 20 percent less water than the current 1.6 GPF federal standard.

QUALIFYING TOILETS & REBATES

3 GPF or greater	1.28 GPF or dual flush	\$100
1.6 GPF	1.28 GPF or dual flush	\$25

PROGRAM RULES & REQUIREMENTS

- Complete a toilet rebate application with signature.
- Provide dated sales receipt with toilet clearly identified.
- Provide proof of decommissioning (one of the following)
 - Photo of old toilet clearly showing it has been removed and decommissioned;
 - A receipt from landfill itemizing the number of toilets disposed of;
 - If applicable, a receipt from a licensed plumbing contractor showing number of toilets removed;
- Customer agrees to allow verification of efficiency & installation by an authorized District representative if requested.
- Applicant must be a District water customer.
- Rebate application must be received within 90 days of purchase.
- *Rebate not to exceed cost of new equipment.
- Limit 3 toilets per NCSD water customer.
- Rebates are available until the annual budgeted allotment is exhausted.
