

NCSD Water Conservation Program Water Flow Monitor Installation Rebate Program and Submittal Information

NCSD offers an at the meter monitoring program, WaterSmart, that issues emails if irregular water flow is detected at your property and allows the homeowner to track their properties water use. However, there are devices available that also detect irregular flow and allow for remote shut-off of water coming into the home. Flow Monitor devices recognize patterns in your home's water use and in the case of an emergency, can assist with remote shut off to the water from entering your home, preventing damage, and saving you on cost from renovation costs. NCSD is offering a rebate for those devices that are installed in-line after the meter, on the consumer's property, provide the ability to remotely shut off water supply, and require professional installation. The Water Flow Monitor Installation Rebate is intended to help customers offset the cost of the installation services of a licensed professional by offering a rebate of up to \$150.

APPLICATION PROCESS

- 1) Complete the Water Flow Monitor Installation Rebate application.
- 2) Supply the dated invoice issued by the licensed contractor/plumber for the device installation.
- 3) Supply proof of purchase for the installed device.
- 4) The above rebate materials can be submitted:

After verification of account holder's name and/or service address, refund checks will be processed within 30-days, and mailed to the mailing address on account, unless a different payee or mailing address is requested on the rebate application.

PROGRAM RULES AND REQUIREMENTS

- The applicant must be a Northstar Community Services District customer.
- Device must assist with the remote shut off to water services at the property, other technology will not be approved by NCSD.
- One rebate per NCSD account per year.
- Rebate not to exceed the cost of installation.
- NCSD disclaims all liability from taxes incurred or any property damage or loss that may arise because of the applicant's or contractor's participation in this program.
- This rebate offer may be discontinued at any time by NCSD.
- Applicant allows verification of repair by an authorized NCSD representative.
- This programs rebate is available on a first come first served basis until the annual budget allotment is exhausted
