



# NCS D Defensible Space Program 6-Yard Green Waste Dumpster Rental Rebate Program and Submittal Information

To encourage Northstar residents to further the community benefit provided by individual defensible space efforts, Northstar Community Services District (NCS D) has allocated \$25,000 annually to reimburse District residents for the rental of a 6-yard green waste dumpster from Tahoe Truckee Sierra Disposal (TTSD). Refunds must meet the following conditions and will be available until all program funds have been exhausted.

## **APPLICATION PROCESS**

- 1) Complete the 6-Yard Green Waste Dumpster Rental Rebate application with a signature.
- 2) Supply the dated sales receipt issued by TTSD for the 6-yr dumpster rental.
- 3) The above rebate materials can be submitted:

After verification of account holder's name and/or service address, refund checks will be processed within 30-days, and mailed to the mailing address on account, unless a different payee or mailing address is requested on the rebate application.

## **PROGRAM RULES & REQUIREMENTS**

- Delivery address must be within District boundaries.
- Customer agrees to allow verification by an authorized District representative if requested.
- Applicant must be a NCS D customer.
- Rebate application must be received within 90 days of rental.
- Limit of 1 rebate per address per calendar year.
- Reimbursement will be limited to the cost of one 6-yr green waste dumpster rental.
